

Terms of Use – MELCloud Hub Website

Introduction

These Terms of Use (the “**Terms**”) cover your use of the MELCloud Hub website (“**MELCloud Hub**”) (homepage accessible at <https://www.melcloud.com> and underlying webpages)

In these Terms, when we refer to “**we**”, “**our**” or “**us**” we mean Mitsubishi Electric Europe B.V.
